### Our mission

The Friends of ERA is a Europe-wide network of individuals and organisations that provide material and moral support to the work and mission of the Academy of European Law (ERA).

ERA was established in 1992 on the initiative of the European Parliament to provide training in European law to legal practitioners. It is a nonprofit public foundation, whose patrons include most EU member states, and which is supported financially by the European Union.

The Friends of ERA Association plays an essential role in helping ERA to fulfil its mission to promote awareness and good practice of European law by providing training and a forum of debate to practitioners of law, including judges, prosecutors, in-house counsel and lawyers in both private practice and public administration.

Founded in 1990 as the Association for the Promotion of the Academy of European Law in Trier, its first task was to raise the funding and political support necessary to establish the Academy itself. Having achieved this goal in 1992, the Friends of ERA turned their attention and resources to other aspects of ERA's work.

One of the projects supported by the association is the Academy's scholarship scheme to enable young lawyers from the new and future EU member states to attend conferences or seminars in Trier.

This scheme can only be financed by the generosity of the association's members and other private donors. The Friends of ERA are drawn from more than 30 countries and from across the legal professions.

In 2025, the association counts 420 individual members and 18 institutional partners from across Europe.


